The Chief Executive, Director of Finance, Director of Environment and Regeneration, and the Director of Housing and Property were in attendance.

1. Minutes – 12th March, 2025

The minutes of the monthly Council meeting held on Wednesday, 12th March, 2025, were approved and signed.

2. **Minutes – 21st March, 2025**

The minutes of the special Council meeting held on Friday, 21st March, 2025, were approved and signed.

3. Minutes – 27th March, 2025

The minutes of the special Council meeting held on Thursday, 27th March, 2025, were approved and signed.

4. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Environmental Services Committee:

What would be the implications of reinstating weekly refuse collections?

Reply by the Chair of the Environmental Services Committee:

Should a Motion be received to return to weekly refuse collections, the following would need to be investigated and considered:

- The exact format required for example this could be refuse only, refuse with a bi-weekly recycling collection service, refuse with a bi-weekly recycling collection and continuation of the bi-weekly garden waste collection service or a different combination;
- The increased ongoing costs to the Council of any one of these formats, which could include the need for additional staff or vehicles, would result in a rate increase assuming an otherwise standstill position.
 - o For example, returning to weekly refuse collection, bi-weekly recycling collection and ceasing the garden waste collection service would result in an additional annual cost of approximately £200,000, adding 1.5% to the rate assuming all else remained the same. Other combinations are likely to cost significantly more;
 - For example, returning to weekly refuse collection, bi-weekly recycling and retaining the garden waste collection service would result in an additional annual cost of approximately £450,000 for an additional vehicle and crew, adding 3% to the rate assuming all else remained the same. In addition, the Council could see a reduction in recyclate income and increased costs at the EfW should people choose to dispose of recyclate instead of recycling the same material. It is impossible to quantify;
 - The one-off costs of city-wide communication to the public; and
 - Any reputational damage to the Council.

5. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Environmental Services Committee:

- 2.1 What are the current percentages of recycling materials for a) glass b) paper c) cardboard d) cans and e) glass, collected through kerbside collection services and what percentage of materials goes to the Energy from Waste Plant?
- What income is currently derived from the sale of the following materials collected through kerbside collection services, a) glass b) paper c) cardboard d) cans and e) glass?
- 2.3 What are the current "gate fees" for disposing of waste materials at the Energy from Waste Plant? Reply by the Chair of the Environmental Services Committee:
- 2.1 For the period April 2024-February 2025:
 - a) Paper 1.47%
 - *b) Plastic* 0.8%
 - c) Card 1.12%
 - d) Cans 0.72%
 - e) Glass 3.78%
 - f) Garden 8.75% (which is also now recycled)

Therefore, the percentage of refuse collected is 83.34% over the above period.

The percentages above represent the total weight of these materials as a percentage of <u>all</u> waste collected over the indicated 11 months. The weights collected in each individual month naturally vary.

- 2.2 For the period April 2024-February 2025:
 - a) Paper £12,415
 - b) Plastic £6,361
 - c) Card £55,230
 - d) Cans £59,508

The Council pays to dispose of glass at an amount per tonne that is **significantly** cheaper (less than 10%) than disposing of glass at the Energy from Waste (EfW) facility. In addition, glass and cans do not have a calorific value and cause operational issues at the EfW.

The Council uses a composter for its Garden Waste. The gate fee for disposing of garden waste in this way is **significantly** cheaper (less than a third of the price) than disposing of garden waste at the EfW facility. In addition, recycling garden waste represents one of the only closed loop recycling systems for the Isle of Man.

2.3 The domestic gate fee at the EfW for 2025/26 is £118.91 per tonne. Commercial gate fees are higher.

Mr Councillor J.E. Skinner asked the Chair of the Environmental Services Committee:

How many people have taken advantage of visiting the Council's recycling processing area to date?

Reply by the Chair of the Environmental Services Committee:

2021 – Five tours plus two Manx National Heritage days (Covid year)

2022 - Four tours

2023 – Three tours

2024 – Seven tours

2025 (to date) - Four tours

The tours are a mix of schools, organisations and the public through the Manx National Heritage Days.

£8,316.
