Please explain your answer:

The eligibility criteria are due to be reviewed as they are far too wide ranging and out of date. The criteria would benefit with being brought in line with other jurisdictions and in some respects are non-compliant with the Equality Act.

Please explain your answer:

There are far too many exemptions, many of which it is difficult to understand why they are included. Part of the concept of a jury is that it represents a variety of people from the area, and across the spectrum of society. It is far too constricted in the Isle of Man.

Although the current system would be easier to administer, and has benefits of being clear with exemptions, however if there is a real issue with shortfall of available jurors and a pool too small for the local population, then this may be worthy of consideration.

The Council don't believe an arbitrator should still apply, if they have a conflict of interest, they can ask to be excused.

- and those members of the staff of the Cabinet Office whose work is concerned with the administration of justice and who have been designated as such, in writing, by the Chief Secretary
- ☐ A person who at any time within the last ten years has been a person falling within any description specified above in this Group

10 years is too long. Three years would be more appropriate. If someone has a conflict, they always have the opportunity to be excused.

Question 7:

Group D – The Clergy etc. - If exemptions by profession were to remain standard practice, are there any currently listed as exempt under Group D that you feel should remain exempt? (Please select all that apply).

In the Council's view, the clergy should be the ones to advise on eligibility.

In the Council's view, these should all be removed.

Question 9:

Mentally disordered persons - Do you think any individuals who would fall under Group F should remain exempt? (Please select all that apply).

- ☐ A person who suffers or has suffered from mental disorder and on account of that condition is liable to be detained (otherwise than by virtue of an application for admission for assessment)

These should all remain as exemptions, as these would cause doubt on the person's capacity to act.

Question 10:

Group G - Disabled persons - Do you think any individuals who would fall under Group G should remain exempt? (Please select all that apply).

- ☐ A person who is certified by a registered medical practitioner to be so deaf as to be unable to perform the functions of a juror

- ☐ A person who is certified by a registered medical practitioner to be suffering from a condition which is likely to persist for more than 12 months

None of these should remain exempt. If they have a medical problem which would stop them attending jury service, they can ask to be excused.
