The Chief Executive, the Director of Finance, the Director of Environment and Regeneration and the Director of Housing and Property were in attendance.

#### 1. **Minutes – 12<sup>th</sup> May, 2021**

The minutes of the Council meeting held on Wednesday, 12th May, 2021, were approved and signed.

## 2. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Housing & Property Committee:

How far behind schedule is the Boiler Maintenance Programme within Council properties given that service engineers were unable to enter residential properties during the last two Covid lockdowns?

Response by the Chair of the Housing & Property Committee:

Because of the statutory nature of the programme, and the danger to life if boilers are not properly maintained, engineers were legally able to enter properties during the restrictions, subject to consent of the tenant and to the appropriate protective measures being in place. There were some exceptions, for example where people were isolating or where tenants declined to give consent. In those cases, an audit trail of the reasons was created, and the engineers moved on to other properties in order to progress the schedule, which has therefore been largely unaffected and is up to date.

#### 3. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Regeneration & Community Committee:

In 1996 Queen's Park received a facelift, some children's play equipment installed and renamed Centenary Gardens as a part the Douglas Borough Council's Centenary celebrations. Since that time there has been very little maintenance and upkeep resulting in the park looking decidedly rundown. Some years ago members of the community were stopped from painting the perimeter wall whilst trying to enhance the aesthetics of the park. When can the residents of the area expect to see action to tidy and paint the walls and railings to improve the facilities and appearance of the park?

Response by the Chair of the Regeneration & Community Committee:

The walls and railings were last painted in 2014 by a contractor. A condition report on all town squares and parks external railings has been obtained and will be subject of a funding bid in the forthcoming budget round.

#### 4. Standing Order 39 Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Regeneration & Community Committee:

How often is play equipment in Council playgrounds inspected and is there a maintenance programme in place for all playground equipment or is it just repaired when broken or damaged?

Response by the Chair of the Regeneration & Community Committee:

All playgrounds and playground equipment are inspected weekly with any issues assigned a task. Dangerous issues are dealt with immediately and other works are scheduled accordingly.
