The Chief Executive, Director of Finance, Director of Environment and Regeneration, and the Director of Housing and Property were in attendance.

1. Minutes – 8th January, 2025

The minutes of the monthly Council meeting held on Wednesday, 8th January, 2025, were approved and signed.

2. Minutes -31st January, 2025

The minutes of the special Council meeting held on Friday, 31st January, 2025, were approved and signed.

3. Standing Order 33 – Motions without Notice

Mr Councillor S.R. Pitts moved a Motion that a written question under Standing Order 39, presented to the Council in private, be considered in public. The Mayor drew the Members attention to Standing Order 74, matters affecting persons employed by Council, which should in the first instance be considered in private. The Mayor therefore did not allow the Motion to progress.

4. Standing Order 39 – Question – Mr Councillor S.R. Pitts

Mr Councillor S.R. Pitts asked the Leader of the Council:

- 4.1 Will nomination papers be available online / council website for the council elections to be held 24th April 2025 to download.
- 4.2 Will guidance notes be available to download regarding the council elections to be held 24th April 2025

Reply by the Leader of the Council:

- 4.1 Yes, nomination papers will be made available to download from the Council's website from 13th March 2025, which is the date that nominations open.
- 4.2 Yes, a candidate information pack will be made available to download / view on the Council's website. The information pack will provide details about how the Council operates including how decisions are made and will cover the schedule of meetings / appointments to Committees to give candidates an overview of what it entails to become a Councillor. The information pack will also provide guidance about the election process and will set out what is required of the candidate to stand as a local authority member.

The information pack is due to be published on the Council's website by Friday 21st February, 2025.

Democratic services intend to host open evenings before nominations open so that anyone interested in standing in the upcoming general election can visit the City Hall and speak to officers to find out more information. Following the close of nominations, training will be provided to all candidates who stand nominated in a contested election.

5. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Housing and Property Committee:

As at the 31st January 2025 how many cases did the Mayor Aldermen and the Burgesses of the Borough of Douglas have before the Civil Summary and Small Claims Procedures Court for Possession?

Reply by the Chair of the Housing and Property Committee:

10 Cases had received Court Dates as of the 31st January 2025, all for rent arrears. However, a number of these have now been adjourned due to payment of rent, with only one tenant due in court. To note a tenant who is required to attend Court will have a number of opportunities to pay their rent through Court ordered payment plans. Possession would only be granted by the Courts should the tenant not engage with the process.

Supplementary Question:

At 15.15hrs, 7th February 2025 there were still twelve cases on the Court List despite two being struck off.

If cases for Possession before the courts are found in favour of Mayor Aldermen and Burgesses does possession lead to eviction, if not, why are we paying for and taking prosecutions?

Reply by the Chair of the Housing and Property Committee:

If the court rules in favour of the Council's Claim and deems that a possession order is appropriate based on the evidence presented by both parties, it will issue a possession order. This order may be either immediate or suspended, up to a maximum of 12 months. The possession order will include a court ordered date by which the tenant must vacate the property and return it to the Council.

The Courts will give the tenant the opportunity to pay the outstanding balance through court ordered payment plans. This is in the best interest of the tenant (not losing their home) and in the interest of receiving the outstanding rent balances.

Only the Court can issue a possession order, if we do not engage in the legal process, tenants will simply not pay their outstanding rental debt and they will remain within the property. This is the only road that we can go down and this is the only way that gives a potential good outcome for both parties.

7. Standing Order 39 – Question – Mr Councillor S.R. Pitts

Mr Councillor S.R. Pitts asked the Chair of the Housing and Property Committee:

- 7.1 What would be the amount of rent that would have been collected on each vacant property in Marathon Drive had they been occupied since they became vacant.
- 7.2 What would be the amount of rates that would have been collected on each vacant property in Marathon Drive had they been occupied since they became vacant.

Reply by the Chair of the Housing and Property Committee:

The Marathon Drive properties have remained vacant as they are not currently suitable for rental due to their poor condition and the significant works and investment required to bring them up to VOID standard. A business case for refurbishment was submitted to the Government in September 2021. However, due to ongoing funding constraints, this scheme has not yet received the required support to allow the Council to move forward with the Scheme.

Discussions with the Government have recently progressed, and an updated report with recommendations on the future of these properties is scheduled to be presented at the March 2025 Housing and Property Committee.

The below table details the total amount of rent and rates that would have been collected had each of the properties been occupied since they became vacant.

Supplementary Question:

What amount of rent would have been available for repairs?

Reply by the Chair of the Housing and Property Committee:

A briefing note will be circulated to Members as the calculation is too complex and cannot be done in the few minutes before Council.

In general this is not how we allocate resources and this is something that we get fairly often with relation to these sets of properties but if we have to make a choice between dedicating resources to getting 1 house repaired in a place like Marathon Drive or getting 10 houses repaired somewhere else obviously we are going to go down the route that gets as many houses repaired for the same amount of resources.

We have been petitioning the DOI to get money to deal with voids, we have received the £700,000, we have allocated 16 houses last Friday, we allocated another 17 today so this process is ongoing. We have had really good discussions with the DOI and Treasury about getting additional funding to deal with these long term problems, these are things that we are aware of and it is not simply the fact that the Council has a bunch of properties that we could repair and we could receive a bunch of money from and we are just deciding to do this, we need to have permission to do this which we are fighting for and we are actioning these sort of properties. So, Marathon Drive is the next main priority that we do want to get dealt with and this is something that we are definitely keen to do. I do need to make it clear that we don't want to leave money on the table and given the decisions we have to make an allocation in meetings between people in dire circumstances. There is no circumstance where we would ever leave a home vacant that we could otherwise be occupied. At the same time we would never allocate a person to a property that is unsuitable to live in and when you have got these multiple competing priorities you have to make tough decisions and this is one of the tough decisions we could have just shoved people in here but we aren't going to do that but I do appreciate the sentiment behind the question and this is something we are going to go out of our way to get delt with.

Have the Council considered approaching Liverpool who are already twinned with Dublin?

Reply by the Leader of the Council:

No, we haven't. However, I will say that when we had visitors over from Liverpool we did talk about twinning, we talked about all sorts of stuff and one of the things that they informally said when we were having this discussion, not directly asking them if they wanted to, but they said that they were more interested in friendship agreements as opposed to twinning agreements and if that is something that we would like to do in the future then I am sure we can take that on board.
